
BIOGRAPHY GEOFFREY BARBER

Introduction

This book assembles together all the known wills and administrations of the Latter families of East Sussex before 1858, after which the Church of England probate courts were replaced by the Principal Probate Registry. It cannot be guaranteed that this is the complete set and future revised editions may be needed to incorporate new discoveries, including non-Latter wills that contain valuable Latter information.

The book provides three indexes which offer great value to Latter researchers. The indexes are:

- 1. Wills by location.
- 2. Index of names occurring in the wills and in associated documents relevant to that will. These additional documents have generally been found by searching the ESRO on-line catalogue which often provides a detailed summary of the document's contents including names, dates and places.
- 3. Index of locations, local place names and properties mentioned in the wills and in associated documents.

These indexes have already facilitated the search for connected wills; that is, wills belonging to one extended family, sometimes a number of generations apart. Each will in this book includes a family tree placing the will in context and highlighting how other wills are connected. The trees are based on many years of research using primarily the Sussex Family History Group baptisms, marriages and burials indexes and are also based on the information gleaned from the Latter wills.

Some of the Latter family trees identified in this document remain "islands" waiting to be connected into a bigger structure. For this to happen, work needs move on from the wills and parish registers to other areas such as the history of Latter property ownership and manorial records where they exist. Many of the Latter families have connections to the county of Kent and further progress will also require much work on the Latter families there.

The author has been a long-time contributor to the Sussex Family History Group Wills Depository project which now has over 13,000 Sussex wills transcribed that are available to members free of charge. All the wills in this book have been contributed to the Wills Depository.

Conventions

The following conventions are used throughout this book:

- The dates shown in the will titles are the probate dates, not the date the will was made (unless there is no probate date). To remove confusion, the year between 1st January and 25th March is written as, for example, 1592/93 wherever possible. Some historians want to leave it as written in the original document (e.g. 1592) and others (in the ESRO catalogue for example) write it as we would today; 1593.
- 2. In the indexes, all variants of the name Latter have been standardised to "Latter" to simplify use of the index. The original spelling of surnames is retained in the will transcriptions.
- 3. The family trees only show the year of events such as baptisms, marriages and deaths/burials. This has been done to simplify the appearance of the tree so the relationship between the people who left wills/admons is more clearly seen. Anyone with a special

interest in a particular tree should verify the dates for themselves. The author is happy to provide charts with full dates for anyone interested (see contact details inside front page). Information concerning any errors or new evidence affecting family tree structures would be welcomed.

Chapter 1 - The Main Family Trees

This section presents the main Latter family trees associated with the Latter wills. The people who left wills/admons are highlighted in each tree which then form a visual index for related wills. These trees are an important part of this book and are the product of many years of research and analysis of parish registers (mostly the SFHG indexes), census records, miscellaneous documents and, of course, the Latter wills. All places are in Sussex except where shown.

It is not possible to put together a single, large Latter family tree and the trees presented below are just pieces in the overall jigsaw. Many of these families have connections to the county of Kent and so require further research there. In some cases there are smaller family clusters which are not documented here in Chapter 1 but instead have been documented with the relevant will. It is possible that further research will enable some of these to be attached to the larger trees in the future.

It is interesting to note that a Richard Latter is mentioned in manorial court records for Walsh's manor in Rotherfield on 4 May 1464 and 11 Jul 1467, suggesting the family has some deep roots in the Rotherfield area.¹

Tree 1. Edmund Latter of Rotherfield and Tonbridge (c1550-)

The Edmund Latter (c1550-) in Tree 1 below is the author's 11x great grandfather and was the motivation to do the research into the Latter wills of East Sussex. He was identified in the Rotherfield manorial records when he gave the property called **Salters** to his son Edmund upon his marriage to the widow Agnes Alchorne (nee A'Downe) on 7 Dec 1602. The manorial records record the transfer:

At this court it is found that Edmund Latter out of court since last court Nov 4th, 45 Eliz [1602] surrendered 1 messuage, 1 barn with garden & 2 pieces or parcels of land containing 4 acres lying at Town Rowe with appurtenances except 1 garden called le forge garden To use of said Edmund Latter his son & Agnes Alchorne widow & the heirs of said Edmund his son But his admission is postponed till next court. And nothing falls for heriot because he remains tenant

² William received the property called Salters from his father in 1638. William died intestate in 1640 and under customary law, daughter Agnes was heir but she died in 1645, so his wife Elizabeth had right of possession until her death and then it would passed to William's brother John. However, John died before Elizabeth, so the heir to the property became John's son, Edmund, but he also died before Elizabeth. After Elizabeth's eventual death in 1680, the manorial court transferred the property to Edmund's brother, John Latter (1654-c1700). He had no children and

transferred the property in 1696 to Elizabeth Hutchinson, wife of Thomas Hutchinson. The Salters property had been in the Latter family for 100 years (1595-1695).

Tree 2. John Latter of Rotherfield (c1575-)

It is reasonable to assume that this family tree connects to Tree 1 at some earlier time. It is even likely that the John Latter (c1575-1662) who starts this tree is a son of Edmund Latter (c1550-) who starts Tree 1. Various documents suggest a close connection between John Latter (c1575-1662) and Thomas Barber who later married into the Latter family in Tree 1:⁴

[Two days later, on 7 Sep 1639, this property was transferred to John Latter's son Thomas (1610-1675)]

In 1639 Thomas Barber married Ann Heath [nee Latter] widow of William Heath and daughter of Edmund Latter (c1575-1656) in Tree 1, suggesting a kinship connection between the two trees.

It would not be unreasonable to assume that John Latter (c1675-1662) is the son of Edmund Latter in Tree 1, however there is no direct evidence so his tree has been kept separate. The argument is strengthened by the names of John Latter's children being very consistent with the names in Tree 1 (i.e. Edmund, Richard, Ann, Alice, John).



This will was proved at London before the Judges for probate of wills and granting administracons lawfullie authorized the second day of January in the yeare of our Lord God one thousand sixe hundred and fiftye sixe by the oathe of **Anne Latter** the Relict and sole Executrix named in the last will and Testament of the said deceased To whome was grannted administracon &c she beinge by vertue of a Commission first legally sworne truely and faithfully to administer.

- 1. The daughter Alice mentioned in the above will as being married to Henry Marten helped to confirm the link to Rotherfield, as Alice Latter married Henry Martin in Rotherfield on 26 January 1624.
- 2. The daughter Anne married Thomas Barber alias Nynne on 7 March 1639 at Frant, Sussex. Thomas died in 1649 (buried Rotherfield 21 May 1649) and Anne subsequently married Samuel Theobold, a clothier, sometime between 1650 and 1661. Although the marriage record has not been found, we know it occurred because on 7 Jan 1661/62 Anne's son Thomas Barber leases the cottage in Rotherfield Town and the Drapers land from Ann and her third husband, Samuel Theobold, who were occupying it: "7 Jan 1661/62 Lease by Samuel Theobold of Tonbridge, Kent, clothier and Ann his wife, to Thomas Barber alias Nine, of Frant, Sussex, then servant to Thomas Weller, gent., of a messuage or tenement, outhouse, barn and stall and a small piece of land lying near the said barn, together with all gardens, closes, backside, etc. in Rotherfield Town. Also, 4 pieces of land and wood containing 22 acres, called Drapyers in Rotherfield; all which premises the said Samuel held by right of An his wife made to her by jointure and lease from Thomas Barber alias Nine, her former husband, father of the above named Thomas. Term, the life of the said Ann Theobold party to the deed and mother of the said Thomas: rent yearly 11 pounds/5s. Signature of Samuel Theobold, and mark of Ann Theobold & seals. Witnesses: William Jeffrey, Ann Barber (mk)". ¹⁰

Edmund Latter was given the property called Salters in Rotherfield by his father (also an Edmund Latter) on his marriage to the widow Agnes Alchorne [nee A'Downe]. It was probably part of a marriage settlement (agreement). The manorial records record the transaction:

Note: This entry is difficult to date from Pullein's transcription but must be after Edmund Latter's marriage to Agnes Alchorne on 7 Dec 1602. It is after a View of Frankpledge court held 7th May 1603.¹¹

At the Rotherfield manorial court held 27 Apr 1638, Edmund Latter transfered the property called Salters at Townrowe [Town Row] in Rotherfield to his son William Latter & Elizabeth his wife & his lawful heirs. William Latter had married Elizabeth Coe on 30 May 1637. It is possible that this is the time when Edmund moved to Tonbridge, where he died in 1656.

Richard Goff, mariner, died in 1718 holding premises 1 above, a parcel of freehold land at Wormy (2 acres), a piece of land (1 acres) held of the manor of Eastbourne Gildredge in Eastbourne and a messuage, barn and land (16 acres) in Jevington, held of the manor of Jevington; all the property had been held by his mother **Elizabeth**, the only daughter and heiress of **Nicholas Pepper** of Eastbourne, yeoman (1).

Premises 2 above had been conveyed to Goff's brother-in-law **Gregory Latter** in 1716 and passed at his death to his son **John**, an infant aged 10 [*aged 1 year actually*] (2).

On **Richard Goff's** death 1 above passed to his wife **Frances** but her estate was challenged by Goff's only sister **Jane**, the wife of **Gregory Latter**, tailor. In 1723 an agreement was drawn up whereby **Frances** was to have premises 1 and **Jane** the 2 acres at Wormy. Premises 1 were therefore conveyed by Jane Latter to **Frances Goff** immediately, but it was agreed that premises 2 should be conveyed to her when John reached 21 (1-2).

In 1736 therefore, **John Latter**, now a farmer of Eastbourne, conveyed the property to **Samuel Williams** of London, carpenter, the only son and devisee of **Frances Goffe**, who had made her will at Bermondsey in 1724 (3-5). **Williams**, of St Mildred Bread Street, sold both properties to **Jane Townsett** of Eastbourne, widow, in 1736 (6-7). On her death in 1750 the property, now called Goffs Malthouse (abutting the highway west and north and a narrow lane leading into Hartfield on the east) passed by her will (in which she describes herself as widow and innkeeper) to her son **John**, with remainder to his son John (8).

In 1761 **John Townsett** the elder of Eastbourne, maltster and **John Townsett** the younger of Eastbourne, farmer, mortgaged the property for 60 to **Mary Gilbert** (1733-1811) of Eastbourne, spinster (10). Richard Goff, mariner, died in 1718 holding premises 1 above, a parcel of freehold land at Wormy (2 acres), a piece of land (1 acres) held of the manor of Eastbourne Gildredge in Eastbourne and a messuage, barn and land (16 acres) in Jevington, held of the manor of Jevington; all the property had been held by his mother **Elizabeth**, the only daughter and heiress of **Nicholas Pepper** of Eastbourne, yeoman (1).

Premises 2 above had been conveyed to Goff's brother-in-law **Gregory Latter** in 1716 and passed at his death to his son **John**, an infant aged 10 [*aged 1 year actually*] (2).

On **Richard Goff's** death 1 above passed to his wife **Frances** but her estate was challenged by Goff's only sister **Jane**, the wife of **Gregory Latter**, tailor. In 1723 an agreement was drawn up whereby **Frances** was to have premises 1 and **Jane** the 2 acres at Wormy. Premises 1 were therefore conveyed by Jane Latter to **Frances Goff** immediately, but it was agreed that premises 2 should be conveyed to her when John reached 21 (1-2).

In 1736 therefore, **John Latter**, now a farmer of Eastbourne, conveyed the property to **Samuel Williams** of London, carpenter, the only son and devisee of **Frances Goffe**, who had made her will at Bermondsey in 1724 (3-5). **Williams**, of St Mildred Bread Street, sold both properties to **Jane Townsett** of Eastbourne, widow, in 1736 (6-7). On her death in 1750 the property, now called Goffs Malthouse (abutting the highway west and north and a narrow lane leading into Hartfield on the east) passed by her will (in which she describes herself as widow and innkeeper) to her son **John**, with remainder to his son John (8).

In 1761 **John Townsett** the elder of Eastbourne, maltster and **John Townsett** the younger of Eastbourne, farmer, mortgaged the property for 60 to **Mary Gilbert** (1733-1811) of Eastbourne, spinster (10). She entered into possession and took the profits and assigned the mortgage to her brother **Nicholas Gilbert** in 1777 (11).
